CERTIFICATE OF INCORPORATION
OF
HUDSON VALLEY TRAVEL BASKETBALL LEAGUE INC.

Under Section 402 of the Not-for-Profit Corporation Law

IT IS HEREBY CERTIFIED THAT:

FIRST: The name of the corporation is:

HUDSON VALLEY TRAVEL BASKETBALL LEAGUE INC.

SECOND: The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-for-Profit Corporation Law.

THIRD: The purposes for which the corporation is formed are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code, and are as follows:

The corporation is organized for the creation, organization, facilitation, promotion, and operation and administration, without profit, of a youth basketball league and related athletic activities among and between community-based programs within Westchester County, New York and the greater Hudson Valley region.

To establish and enforce rules, standards, and policies governing league play, including player and team eligibility, scheduling, officiating, and sportsmanship.

To promote the development, education, health, sportsmanship, teamwork, discipline, and ethical conduct of youth through organized athletics.

To collect fees, accept donations, pay reasonable compensation in furtherance of the corporation's exempt purposes, and to do any other act or thing incidental to or connected with the foregoing purposes.

The Corporation shall have no members.

FOURTH: The corporation is not formed for any purpose requiring consent or approval of any state official department, board, agency, or other body.

FIFTH: The corporation is a charitable corporation under Section 201 of the Not-for-Profit Corporation Law.

SIXTH: The office of the corporation is to be located in the County of Westchester, State of New York.

SEVENTH: The names and addresses of the initial directors of the corporation are:

EIGHTH: The Secretary of State is designated as agent of the corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the corporation served upon the Secretary of State by personal delivery is: 24 Seely Place, Scarsdale, NY 10583.

NINTH: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this certificate, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so distributed shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes.

In any taxable year in which the corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code, the corporation shall distribute its income and comply with the requirements of Sections 4941 through 4945 of the Internal Revenue Code.

No part of the activities of the corporation shall be for pecuniary profit or financial gain of its members, directors, or officers, except as permitted under Section 501(c)(3) of the Internal Revenue Code.
